GENERAL POLICIES, TERMS, AND INFORMATION

PRICES AND CONDITIONS Prices are determined and based on Quality Compressor providing a remanufactured compressor in exchange for a remanufacturable core. An additional charge will be made if crankshaft, casing, stator or rotor cannot be remanufactured or if parts are missing when core is received by Quality Compressor.

The exchange price will be the basis for billing. Exchange prices are LIST figures and are subject to a discount multiplier. Customer will be billed for core charges if old compressor core is not returned to Quality Compressor within 30 days of shipment date of remanufactured compressor. Core charges are NET figures.

PAYMENT TERMS Payment terms are 30 days NET unless agreed otherwise. Quality Compressor reserves the right to add an appropriate 1-1/2% service charge, (or the minimum allowable interest rate) on the principal amount due on any outstanding accounts/bills at the end of each month. Credit Privileges will be withdrawn on all past due accounts.

TAXES Additional to prices published and quoted by Quality Compressor, the buyer/customer shall be liable for all appropriate taxes.

FREIGHT TERMS All merchandise is sold F.O.B. Quality Compressor's warehouse, Bell Gardens, California. All compressors are shipped freight collect, unless arranged otherwise. The company's responsibility and liability ends upon delivery of goods/merchandise to carrier. Claims for goods/merchandise damaged are to be submitted to and/or handled by the specific carrier. Old compressor cores should be shipped to Quality Compressor by pre-paid freight only, unless other arrangements have been made.

LIABILITY Quality Compressor shall not be made liable for loss or damage caused by any delay due to fire, strike, labor troubles, government regulations, transportation, acts of the elements, acts of God, or failure to receive materials and/or causes of a like and/or different nature reasonable or otherwise beyond its control.

ADDITIONAL TERMS

In the event any action at law or in equity is commenced to enforce or to interpret the terms of this Agreement, the prevailing party shall be entitled to actual attorney's fees and costs incurred.

This Agreement is intended to represent the entire agreement of the parties with respect to its subject matter, and it supersedes and merges all prior and contemporaneous negotiations, agreements, promises and representations.

This agreement may only be modified by a writing signed by the parties to be charged with the modification, and it may not be modified or amended orally. Customer acknowledges and agrees that Quality Compressor is not bound by any terms and conditions set forth in any writing which has not been duly signed and accepted by a corporate officer of Quality Compressor.

If any term of this agreement is held by a court of competent jurisdiction to be void or unenforceable, the remainder of the contract terms shall remain in full force and effect.

1-YEAR LIMITED WARRANTY REMANUFACTURED COMPRESSORS

Air Conditioning and Refrigeration compressors are not unconditionally guaranteed. Please read the following warranty conditions carefully, and advise your customers accordingly.

QUALITY COMPRESSOR warrants its compressors, parts, and other refrigeration and air-conditioning equipment to be free from defects in material and workmanship under normal use and service. Our obligation under this warranty shall be limited to repairing or replacing, F.O.B. Bell Gardens, California, any compressor or part thereof which our examination and inspection shall disclose to our satisfaction to be thus defective, and does not disclose any misuse, alteration, neglect, abuse, accident, failure due to adverse power conditions, contaminated systems, liquid refrigerant in compressor, lack of suction or water cooling of compressor, misalignment and excessive end thrust, and/or other extraneous causes.

QUALITY COMPRESSOR will not be responsible for, nor accept charges for loss of refrigerant, oil, crane, freight or labor expenses, consequential, incidental or special damages incidental to the replacement of compressor or parts under this warranty.

On all compressor replacements of burn-outs, the above warranty will be totally void unless system is thoroughly clean and a new suction line filter and liquid line filter-drier are properly installed in the system.

The above warranty shall be for a period of ONE YEAR from date of shipment on ALL semi-hermetic and open-drive compressors.

This warranty shall apply to the original purchaser and shall be in lieu of any other warranty, expressed or implied, or statutory, including but not limited to, any implied warranty or merchantability or fitness of any particular purpose.

CAUTION: When an air conditioning or refrigeration compressor fails while in service, the cause of failure should be determined and eliminated. Unless a system malfunction is corrected, the replacement compressor will also fail.
